Friends of South Walton Sea Turtles, in partnership with Visit South Walton, will once again host the International Coastal Cleanup in 2020. The Volunteer Beach Ambassador Team invites all community members and visitors to the Emerald Coast to join in the efforts to clean up the beaches of South Walton on Saturday morning, September 18th, from 9:00 to 11:00 a.m. "We will work with little pomp and circumstance," says VBA director Laurie Reichenbach, "but rather with a heart for serving our community and our beautiful coastal environment, and to gain the sense of serving for the greater good of Walton County and the health of the marine and bird life that make the Gulf of Mexico their home. Will you join us? Can we count on you?"

Walton County Launches Virtual Public Comment Process for Public Meetings


The Walton County Board of County Commissioners has approved a process to allow members of the public who cannot attend a County public meeting in person the ability to provide virtual public comment.

This new process will be instituted beginning with the August 10, 2021 regular meeting of the Walton County Board of County Commissioners. Following this meeting, this process may be refined and will be available for future meetings of the Board of County Commissioners, Planning Commission, Tourist Development Council, Design Review Board, Technical Review Committee and Zoning Board of Adjustments.

To virtually participate, members of the public will be required to submit a registration form request 24-hours prior to any meetings and are required to submit specific request on which agenda items they would like to comment on. Virtual public comment will not be authorized during Quasi-Judicial hearings.

The guidelines for participation are as follows:

Virtual Participants will need to register by completing a Public Comment Form by going to the County's website at Virtual Public Comment Instructions. A separate registration will be required for each meeting. Registration must be completed at least twenty-four (24) hours before the start time for the scheduled meeting. Registration must include the agenda item(s) during which the participant wishes to speak. Virtual participants will be limited to five (5) items. Virtual participants will not be allowed to speak on any items for which they have not pre-registered except for the open public comment item at the end of the meeting.

Virtual Participants must log-in to the meeting at least fifteen minutes prior to the

scheduled meeting start on the day of the scheduled Board of County Commissioners meeting to comment on items on the Consent and Regular Agenda of the meeting. Virtual Participants providing comments for items listed on the Public Hearing section of the Board of County Commissioners Agenda, or for any item listed on the Planning Commission agenda, must log-in to the meeting at least fifteen minutes before the scheduled start of the Public Hearing portion of the Agenda on the day of the scheduled meeting.

All Virtual Participants will be emailed a participation link and must utilize the link provided to participate. All participants must enable their cameras thus providing an active video connection. In addition, the connection name must be their legal name and the name submitted under the request. Audio only connections will not be recognized.

During the meeting, Virtual Participants will be notified by the Chairman, the Clerk, or a member of County staff, when they will be permitted to speak.

Virtual Participants are subject to the same time limits as in-person participants. Land use applicants with items on the regular Public Hearing agenda shall ensure that at least one person with authority to make binding commitments relating to the application is physically present at the meeting. Because any person can attend

the meeting in person, Virtual Participants, when registering to participate virtually, assume the risk of any technology issues that may prevent their comments from being heard properly. If technology issues arise with Virtual Participants, the Board may elect to either disregard their comments, or continue the item until the technology issues have been resolved, or until the Virtual Participant(s) can attend the meeting in person.

Little Free Library



Rockwell and Tharp Have Come a Long Way!

Cameron, a rather unassuming man, was working as an international business consultant, and Kristi was working as an intensive care trauma nurse. Both were born and raised in Alabama—Kristi in Birmingham and Cameron in Mobile. As fate, or perhaps faith, would have it, both were compelled to return home to care for their ailing parents. The experience would create a bond destined to transition their lives in a whole new direction.

Cameron says the idea of designing custom boot wear came from a desire to combine their natural creativity with their love of travel. On a trip overseas, they designed prototypes for friends and family members. “The original boots we produced were a beautifully embroidered, knee high design,” says Kristi. Cameron remembers the first time Kristi wore them. “We couldn’t get through the airport without ladies stopping us and asking where they could buy a pair. That’s when we realized we were on to something.”

The couple began selling a collection of 10 designs to boutiques throughout the U.S. and Canada. The business grew, and over the years, Rockwell Tharp has had the privilege of designing boots and handbags for hundreds of stores. The duo has been commissioned to design many boots for celebrities around the world, such as the bands Heart, Survivor and Quiet Riot – and their wives! Rockwell Tharp has been featured on The Today Show with Kathi Lee Gifford and Hoda, CBS News, The History Channel and American Idol.

In 2016, the couple decided to settle down and make Sandestin home and in 2017 opened the Rockwell Tharp Ladies Boutique, choosing the Village of Baytowne Wharf for its permanent location. This is the only store in the U.S., where you can see the entire collection of boots and handbags in one location, including limited editions.

Why Is Inflation Rising Yet Treasury Yields Are Not?

The latest reads on inflation have it running at levels not seen in over three decades—CPI at 5.4%, PPI at 7.2% and PCE at 3.9%. One report after another sends the signal that inflation is taking hold. Many economists and even the Federal Reserve (as well as the White House) strongly suggest that this is transitory. That it is the result of the economic reopening and the supply chain disruption. That supply chain disruption, as we understand it now, includes the labor supply. The U.S. seems to be facing a labor shortage in some industries. That has led to wage inflation as well. Wage inflation is usually the last thing to follow price inflation. As we have mentioned before,

we feel present-day inflation is the result of the stimulus – the creation of additional dollars by the Federal Reserve. This is also known as monetary inflation.

With inflation and the economy “running hot,” would it not seem to follow that it would 1) put pressure on the value of the dollar (downward) and 2) put pressure on bond yields (upward) and mainly Treasury bond yields? The strange phenomenon occurring, however, is that inflation is rising, yet bond yields are declining. To many that does not seem to make sense. The financial media are full of thoughts as to why this might be occurring. Here are a few thoughts for you.

CNBC recently reported that some (unnamed sources) say that investors and institutions have locked in the significant gains they have seen this year and are selling their stocks and parking those gains and funds into Treasuries. Other reports point to de-risking by investors in anticipation of economic slowdowns due to the spread of the coronavirus. We have been researching other periods of high debt relative to GDP. One thing we take note of is the post WW2 period where the U.S.’ debt to GDP ratio



was 108%. A rate many would argue was not sustainable. What happened over the next decade, for several reasons, was that the debt to GDP ratio shrank to 40%. The U.S. inflated its way out of that high debt ratio. In other words, the economic growth far outpaced the debt.

That begs the question: Is that potentially happening again? In other words, is one of the ends in mind is to inflate the country out of the high debt ratio we are currently in? Actions by the Fed - and words from The White House - give us reason to consider that the Fed’s easy monetary policy is likely to continue, and that inflation is real and not transitory. Inflation ran at under 2% for the past generation and a half and now could be running at 50 – 100% higher than that for the foreseeable future. We figure that to make inflation 3-5% over the next few years.

What this means to investors is to look at their holdings in terms of not only risk, time frame and objective, but also in terms of real return. Real return is the rate of return left after the rate of inflation. Current CPI rates would mean an investment returning 5% has a real return of -.4%. That means shrinking vs. growing purchasing power. Higher rates of inflation typically bring higher rates in yields and savers and income investors have yet to see that. That is so because there are more buyers than sellers for bonds, mainly Treasury bonds. The near-term impact (with the caveat that corrections could literally happen any hour of any given trading day) could mean that, along with the tremendous amount of liquidity out there, stocks, real estate and commodities have greater upside potential than downside risk given the strength

of the economic recovery and the increased earnings corporations are experiencing. You need to go a step further with stocks and focus on those that are inflation resistant or inflation resilient. Those would be the value stocks and funds like cyclical, industrials, financials and the like. Real estate could mean buying land, dwellings or perhaps utilizing REITs in the stock market.

Such scenarios have not always favored growth-oriented investments such as technology stocks. Do take note that over the most recent short-term technology has had a strong recovery when considering the 2Q of this year. Investors do not want to ignore the innovation and profitability that technology can bring. We think investors should add to or begin building value-oriented holdings, but not necessarily rotate out of growth-oriented holdings.

Should rates resume their rise again (The U.S. Treasury 10-year note was at 1.77% in March and is at 1.29% at this writing), we believe, based upon historical reactions, that rates would need to rise to 2.75% for investors to begin to see the negative long-term effects that would have on equities (stocks). The 10-year U.S. Treasury note is an often turned to barometer for the stock market as well as for mortgage rates. The 30-year is more associated with inflation.

This, of course, addresses investments as a class vs. looking at certain sectors or segments of the market. We still believe in the words Warren Buffet spoke when he urged investors to focus on buying great businesses vs. just buying investments. We would add to that to be a buy and hold investor until your objectives, risk tolerance and time frame change.



Walton County Improves Test Performance Ranking During Pandemic

State Assessment Results Released

On Thursday, the Florida Department of Education released the results from the Spring testing window, which most parents and students may know as FSA (Florida Standards Assessments), FCAT (Florida Comprehensive Assessment Test), and EOC (End of Course) exams. These tests include the FSA English Language Arts (grades 3-10); FSA Math (grades 3-8); FCAT Science (grades 5 and 8); and EOC exams in Biology, Algebra I, Geometry, Civics, and US History.

Walton County’s Superintendent, A. Russell Hughes, and his team were anxiously awaiting results and began to analyze school, district, and state data immediately. Initial data analysis shows that Walton County ranks 6th in the state among all 67 counties on the 21 state tested areas. This is an improvement from 8th in the state two years ago; the last time the state assessments were given. Superintendent Hughes commented, “This represents an improvement of 109 ranking points.”

Of the 21 tested areas, Walton County students rank in the top 10 of all districts in 16 of the 21 areas tested, including 4th, 5th, 6th, 7th, 9th, and 10th grade English Language Arts; 4th, 5th, and 8th grade Math; 5th and 8th grade Science; Biology; Algebra I; Geometry; Civics; and US History. More specifically, Walton County students ranked 3rd in the state in the areas of 9th and 10th grade English Language Arts; 4th in the state in 6th grade English Language Arts, 5th grade Math, 5th grade Science, and in US History. Also

topping out the top 5 ranking was 5th grade English Language Arts and Civics.

Superintendent Hughes gave all the praise to the entire Walton County School District system. He stated, “We all know the challenges that confronted our schools regarding COVID-19. A year never to be forgotten, but the vision I set forth for us was Hang On & Gain On and I am ecstatic to report that we (ALL STAKEHOLDERS) did just that in the midst of an International Pandemic. It truly is what EPIC compels us to do!

LIFTOFF is a supported employment service for people with developmental differences. Westonwood believes that the best

way to learn is through doing. The program is designed to bridge the gap by providing hands-on experience in small business operations, which includes aquaponics farming at the ranch as well as the preparation of gourmet dog treats baked in the Westonwood kitchen.

Recently, the individuals at the ranch had an opportunity to pay a visit to the Watercolor Inn. The participants had the privilege of engaging in a variety of activities that gave them real life experience in the hospitality industry.

The visit to Watercolor Inn was only the first of many planned explorations for the participants at Westonwood Ranch. The purpose of these visits is primarily to provide hands-on experience in all types of job opportunities available. A large part of the LIFTOFF program is that the

participants venture out into the community to see what types of jobs would be available to them in the future.

There were a myriad of benefits to all parties involved with the visit to the inn. The end goal of the LIFTOFF program is, of course, for participants to gain employment in the local community. Visiting the inn allowed these individuals to see potential job opportunities that were available within the hospitality industry, and as well as gain the experience of "doing," and see what life would be like as a Watercolor Inn staff member. In addition, Watercolor Inn is excited to add more people with developmental differences to their team, and this opportunity allowed the team with the inn to see the mutual benefit of having individuals with developmental

differences working with them, and generated excitement to see who would apply in the future.

St. Joe Clubs and Resorts, owners of The Watercolor Inn, has been a close partner with Westonwood Ranch from the beginning. They've helped with a variety of fundraising events, served as volunteers in their programs, and occasionally visit for a work day on the ranch. "Being a nonprofit organization, we know how dependent we are on community members to invest not just financially in our organization but with their hands and hearts. St. Joe Company and its employees that work in Walton county truly embrace the "give back" spirit and believe that it's not enough to just operate a business here, you have to invest back into



the community to leave a lasting impact," executive director Kelly Cash, commented.

The Man in the Arena

"This was a righteous fight—a fight for truth. There's God and truth. I couldn't have faced this without God and the truth."


When local resident and retired Navy SEAL Chief, Eddie Gallagher, was suddenly arrested on September 11, 2018, at the medical facility where he was receiving treatment for traumatic brain injuries, he had no idea why. "We were told to take you to prison," said the authorities. Eddie kept saying, "This is a mistake," completely confused.

Little did he know at the time that he and his wife, Andrea, would be in the fight of their lives the next 10 months. He was taken to a military brig and held in solitary confinement without being told what he had been arrested for or how long he would be there.

Eddie joined the Navy at age 19, his dream to become a U.S. Navy SEAL. For almost 20 years, he served as a Navy Corpsman, Marine Scout Sniper and, yes, Navy SEAL earning a stellar reputation along the way. Eddie deployed eight times, including to war zones in Africa, Iraq and Afghanistan. In 2014, Eddie "Chief Gallagher" was named the Sailor of the Quarter and then Sailor of the Year for NSW Group One (all West coast-based SEALs). During his career, Eddie was awarded two

Bronze Stars with V for Valor, Meritorious Unit Commendation, Presidential Unit Citation, two Navy Commendation Medals, three Navy and Marine Corp Achievement Medals—one with V for Valor and five Good Conduct Awards. On his last combat deployment to Iraq in 2017, Eddie led a platoon to successfully defeat ISIS in Mosul. For his performance and leadership, he was highly commended upon returning home. He was named the #1 Navy SEAL Chief, nominated for a Silver Star, and slated for promotion to Senior Chief. He was then awarded a coveted training billet for his 'twilight tour' as a SEAL.

However, despite this record of success and impeccable reputation, Eddie would spend nine months in prison largely being denied medical treatment, access to legal counsel and regular visits. In the initial few days of his arrest, he knew he was in a very different fight. A turning point came two months later during a phone call with Andrea when, "We both realized that the only people that could fight were us. I gave everything to God and was willing to accept His outcome," says Eddie. "And at that moment, I literally felt a weight lifted off my shoulders—I had a peace knowing God was taking care of me." Andrea's faith led her to acknowledge they were going through this ordeal for a



reason and should listen to God. From that time on, they did. Eddie says being locked up puts you in a darker place mentally. "But, over 100 different times, God showed me this would be o.k." And he tried to keep his mind in the right place by serving. "I was able to mentor some of the younger guys by doing workouts with them. I could really see a difference in them."

Andrea fought tirelessly to raise awareness about the injustice they were facing. "She took all of her professional knowledge and applied it to me while also taking care of our three children and everything else. She is my hero," says Eddie.

In the end, Eddie was proven innocent and acquitted of all serious charges. "The amount of people that supported us was amazing. People like Bernie Kerik, former NY police commissioner, were very influential in helping us," says Eddie. "And I was continually

praying. I even prayed that God would have the president step in."

The magnitude and terror of the ordeal that Eddie and his family went through will never leave them. "We learned how broken the system is, that our service members and first responders can be unfairly and unjustly targeted, and how vital outside help can be in fighting back against this kind of corruption," says Eddie.

So, Eddie and Andrea have founded The Pipe Hitter Foundation (pipehitterfoundation.org), a non-profit dedicated to support men and women in both the military and law enforcement who are facing similar injustices. "The Pipe Hitter Foundation is committed to defending the rights and freedoms they risk their lives to uphold."

They have also written a newly released book, **The Man in the Arena**. The book features never-before-revealed details of Eddie's experience fighting for his freedom. He holds nothing back when explaining how and why he feels several malcontents in his SEAL platoon conspired to frame him for war crimes.



Eddie also explains exactly what happened that May afternoon in Iraq when after a fierce battle with ISIS, a terrorist was brought to the SEAL compound for medical aid and died in their care. Andrea wrote several chapters from her perspective, comparing Eddie to the Old Testament's Joseph, who was betrayed by his brothers and sold into slavery in Egypt.

Their book has already become a "Best Seller" on Amazon, number one in several categories, and the number three bestselling book overall. You can personally meet Eddie at his upcoming book signing hosted by Clemenza's at Uptown Station, Thurs., Aug. 12, 2021, from 6 – 8 p.m. (75 Eglin Parkway, Suite 126, Fort Walton Beach, 32548). "We didn't want to play the victim—we learned and grew from the situation; it was a nightmare, but we want to turn it into a positive. Not playing the victim role will serve you well. I now have more of an appreciation of being around my family and a whole new outlook on life. We're just moving forward..." —Eddie Gallagher


ECCAC Welcomes WCSO Sgt. Khaliqa Wheatley to their Board

Journey Bravely; Survival Mode Recovery

Have you found yourself coming out of a difficult time of crisis wondering “What do I do now?” Maybe you battled the illness and rang the bell. Maybe you moved and found yourself trying to resettle. Maybe you

went through a painful loss or ending of a relationship and find yourself trying to pick up the pieces.

Your body and brain are uniquely suited for managing stress and will often automatically go into survival mode when life gets overwhelming. For a time, you can survive on less sleep, less adequate nutrition, and less than ideal coping skills. Your brain moves away from higher level thinking tasks and focuses on the next step you must take to get through the day. Survival mode is a biological gift while you’re in the midst of high stress and emotional turmoil that might otherwise take you down.

When your stress is prolonged and intense, it can be

hard to figure out what you’re supposed to do when the stress subsides. It can take your body and brain time to catch up with your circumstances and return to a calmer state. So, how can you intentionally help your body and mind recover from the heightened state of survival mode?

5 Self-Kindness Practices to Promote Survival Mode Recovery:

Create space for backlogged emotions. Often during times of high stress, your brain sorts overwhelming emotions to the side to support your daily functioning. When the crisis ends, you may experience large waves of emotion pertaining to the crisis. Let yourself feel without judgement. Your emotions don’t need to be rational. They simply need pathways to escape your body to complete the release of stress. Let yourself cry, create, be athletic, journal, go to therapy, vent to a friend, punch a punching bag. Releasing emotion provides a pathway for your body to a normal state.

Create space for rest. Often during a crisis, rest falls off the priority list. When the crisis ends, you may find yourself physically and mentally exhausted. You may feel forgetful, confused,

fatigued and irritable. Take naps, prioritize healthy sleep patterns, read a book for leisure, take a weekend away.

Return to healthy practices. During crisis, things like taking walks, attending small groups, yoga, deep breathing, and personal growth reading become hard to continue and often disappear entirely. When life calms, remember healthy practices that provided life-giving foundation before the crisis. Try choosing one or two healthy practices and slowly and consistently returning to them.

Be aware of numbing activities. Under intense stress, most people begin unhealthy coping skills to numb and avoid facing difficult emotions. Common numbing activities include substance abuse, eating to medicate feelings, overspending, bingeing shows, bingeing social media, engaging in unhealthy relationships. Try not to judge yourself harshly when you identify numbing. Instead show grace to yourself. You’ve been through something hard. Try acknowledging your numbing and intentionally begin substituting healthier practices and coping skills. Ask for help if your numbing has become addictive.

Pursue joy. When you’ve been through something hard, it’s not

unusual to notice you’ve begun trying to protect yourself from joy. Joy can be as vulnerable as hurt and sadness, especially when faced with imagined or actual traumatic loss. Your brain might trick you into believing you will experience less pain if you avoid joy. Try telling yourself the truth that experiencing joy is not going to create more pain. In fact, avoiding joy simply robs you of joy. When hard times come, the joy you allow yourself to experience is much more likely to bring comfort than to intensify pain.

As you take steps to move from crisis to normalcy, remember to be kind and patient with yourself. Harsh words and self-criticism are unproductive and feed depression, anxiety, and discontent. With care and intentional practice, your body and mind will sync up with your life circumstances. Know you aren’t alone and survival mode recovery is a natural part of the human experience. Also, be on the lookout for increased insight that comes through suffering that may surface as you recover, as well as, a deeper compassion you may have for others going through what you’ve recently experienced. Cleansing: 4 Key Steps

One of the greatest gifts you can give yourself is the gift of health. There may be no better gift than doing a whole food cleanse. Will it be easy? Maybe, maybe not. Do you need it? Most likely. Do you deserve it? YES!

After facilitating and participating in a Whole Food Cleanse for years, my clinical and personal experience tells me that everyone would benefit from cleansing. This is a quick overview of how to prepare for success.

Set your goals and have a plan

Setting realistic goals is extremely important when making decisions regarding cleansing your body. Often weight loss is a primary goal, yet it needs to be realistic. If you're doing a 10 day cleanse, don't expect to lose 20 lbs. Usually men lose weight at a much more

rapid pace than women, yet we all will lose weight and get to our ideal size when we sustain healthy eating habits. Typically with the 21-day cleanse we facilitate, men on average lose between 8-15 lbs and women lose 5-10 lbs.

Sustaining your new health with improved eating habits should be among your goals, with weight loss being a side effect. Other realistic health goals should include reducing inflammation, joint pain, hot flashes, and even improving sleep. All are side effects of ridding our bodies of toxins and restoring our digestive and elimination systems.

Have a plan beyond "I'm going to eat better."

A good plan includes what will you eat? How often? Real food or packaged? If you're using supplements, which is often the key to restoring your digestive and eliminative systems, be sure they

do not contain any stimulants or appetite suppressants. All your supplements should be "Whole Food" supplements.

Have support and accountability

Being part of a group, or having a coach, nutritionist, or your doctor is a great advantage. Have someone in your corner who can help keep you on track and accountable when things get challenging. Find someone with a good knowledge base and experience. Your surroundings are often a major influence on what you eat and drink. Ideally your spouse or close friends are cleansing with you so you aren't tempted to stray off track.

I find that most adults have no idea how much power sugar and chemicals have over our bodies until we give them up. Keep in mind that simple carbohydrates like bread, alcohol, muffins, crackers all act just like sugar and will need to be avoided in any successful cleanse.

Understand your symptoms

What Does Proper Hydration Do For You?

We’ve all heard that we need to drink a lot of water every day with varying opinions as to how much that should be. So, what does drinking water do for us?

Water is used by every cell, organ and tissue that makes up the body and nearly all of the major systems in the body depend on it. It is also the medium for most chemical reactions in the body, especially those metabolic reactions

- involved in energy production. It’s necessary for all digestion and absorption functions, and lubricates mucous membranes in the gastrointestinal and respiratory tracts. It also:
- Transports oxygen, nutrients and waste in and out of the cells
 - Regulates body temperature
 - Moistens tissues such as mouth, eyes and nose
 - Protects body organs and tissue
 - Serves as a cushioning component between joints, in the spinal cord and in the brain
 - Lessens the burden on the kidneys and liver by flushing out waste products
 - Carries nutrients and oxygen to cells
 - Helps dissolve minerals and

- other nutrients to make them accessible to the body
- Helps prevent constipation
 - Composes 75% of our brain, 83% of our blood, 75% of our muscles and 22% of our bones
- Our bodies lose water through breathing, sweating and digestion. And, when our sugar levels are high (what are we eating?) the body needs a lot of water to leave via the kidneys (ratio of 6 molecules of water for every molecule of sugar). If water is not being drunk, the body’s cells are being used to compensate and dehydration sets in. Signs of dehydration are:
- Feeling thirsty (Sometimes when you’re feeling hungry, your body is really saying I’m thirsty.)
 - Skin looks dull and wrinkles and fine lines are more apparent

- Tired or sleepy, dry mouth
 - Decreased urine output
 - Headaches and/or dizziness
- The current trend for how much we should drink is half our body weight. However, if you’re a very active person (exercising, playing sports, running, hiking, etc.) your intake should increase. And, coffee, tea and other beverages made with water should not be counted toward your daily intake. These drinks are not recognized by the body as water and are not processed the same way water is.
- 60-80 ounces is a good range. (Urine should be light yellow to clear when you’re hydrated.) To increase your intake, start with one extra glass a day and increase it every week or so until you reach your goal. (Take time to measure how much water your favorite glass holds.) Let’s say your glass holds 10 oz. and your target is 70 oz. You’ll need

to drink seven glasses each day. A great reminder is to place seven rubber bands at the top of your glass. Every time you empty the glass move a rubber band to the bottom. This visual lets you know whether you’re drinking water or not. (I drink a 12 oz. glass of water as soon as I get up which makes my goal much easier.)

If you’re one of the many people who don’t really like water, consider purchasing a diffuser bottle. This allows you to add flavor by adding berries, melons, lemons, limes, etc. to the water. Play with mixing different flavors to find your favorite.

As with any lifestyle change, consistency is key and progress (smaller steps toward your goal over time) can produce amazing results.

Her mother sat at a blackboard, teaching kids the cosine.

Meantime, if the little girl wasn't playing in dirt, she was usually eating. She has always been a great lover of food. Namely, cake. Cakes of all kinds. But also candy bars. You never saw anyone love candy bars more.

Her favorite candy bars were as follows: Pay Days, Baby Ruths, Snickers, Almond Joys, Butterfingers, Heath bars, Milky Ways, Hershey's bars, Mounds, Crunch bars, Kit Kats, Mars bars, Three Musketeers, Twix, Reese's Peanut Butter Cups, and pretty much anything else that

comes in a wrapper and isn't good for your teeth.

And don't even get the little girl started on ice cream.

One of the girl's inherent gifts was the ability to make flowers grow. She was good at it. Some people just are. This is why throughout the girl's lifetime her fingernails were often dirty, her skirts were stained with soil, and her arms were usually tan.

When she got a little older she went to Huntingdon College, a Methodist school. She left her Alabama hamlet, driving in her first-ever automobile. She took Highway 31 straight up to Montgomery, seated behind the wheel of a giant gray Plymouth that looked like a seasick Moby Dick.

The car was junk. Sometimes it didn't even crank. And once you got it going, if you braked at an intersection the engine would die. So, she learned to completely ignore stop signs. A lifelong habit she would carry into old age.

Going to a Methodist college

was fun. Like all good Methodist girls, she would often sneak beer into the dorms, icing longneck bottles in the lavatory sinks, trying hard to ignore the framed portrait of Jesus on the wall.

Late at night, the girls would all congregate in someone's room, sitting on filthy dormitory floors, eating homemade cookies and smoking unfiltered cigarettes. They would burn the midnight hours laughing and discussing the philosophical topics that all devout Methodist girls discuss.

Methodist boys.

But mostly the girls just rode around in that hideous car. They took famously fun trips through town. And whenever the ugly car would approach a busy intersection, local traffic cops, who recognized the vehicle, would halt traffic to let the girl's Plymouth blitz through the stoplight so she wouldn't have to tap the brakes.

When the car rolled by, five or six beautiful girls leaned out the windows, blowing kisses to

the patrolman, hair flying in the wind, all screaming, "Thank you, officer!"

And it was probably the greatest day of that officer's life.

The girl eventually married. She settled down. She had kids. Three of them. Two girls and a boy. She had a cute house. A nice backyard. Many colorful flowers.

She did the usual mom stuff. She changed cloth diapers, attended school plays, went to Little League games. She was in Civic League, she made ridiculously good deviled eggs, and she could whip up a tomato chutney that made grown men see visions.

And then she grew old.

It all happened so fast that hardly anyone noticed. Why does age work like that? Why do the years get shorter? Why does life itself whirl past us at a breakneck tempo?

Her lifetime went by like a veritable blur. Often she wonders where it's gone. It seems like only yesterday afternoon that her lean, youthful body was seated behind the great wheel of that godawful Plymouth.

Today, however, she lies in her



hospice bed, drifting in and out of consciousness. She stares out her bedroom window, looking at her rainbow of geraniums, begonias, pansies, lantana, impatiens, and hydrangea-like clusters.

I'm sitting beside her, writing this.

My thoughts are interrupted when she struggles to speak through the confusion that overwhelms her mind. But eventually she gets the words out so that we can understand her.

"Please," she says. "Don't forget to water my flowers."

We won't, of course. We will never forget. Because we all know how much this girl loved playing in the dirt.

Lemons to Lemonade

In 1961 Marty Robbins had already enjoyed success on country and pop charts through such ballads as “A White Sport Coat” and “El Paso.” Yet one of his more interesting numbers could well have been “Don’t Worry,” another crossover tune. Through error, the track became one of the earliest examples of guitar distortion. Session guitarist Grady Martin relied on a faulty channel in the mixing desk for his six-string bass, to eventually create what would be a distorted, fuzzy sound, not too unlike what one might expect from a blown amplifier.

Billy Swan was another

reasonably successful rock and country writing and recording artist in the 1970’s. In 1974 he charted his most successful release, “I Can Help,” which peaked at #1 on the country list and #6 on Billboard’s Hot Adult Contemporary Singles for pop. Distinctive, from the soft sounds of a borrowed Farfisa keyboard, perhaps even more remarkable was the applause and encouragement of session musicians at the end of the song. You see, Billy had recently taken ownership of a German Shepherd puppy, Bowser, who was already faithfully at his side during the recording, gnawing and tugging on his trousers



throughout the recording. The response at the conclusion was one of admiration for Billy Swan having triple tasked singing, keyboarding, and swatting away a playful canine.

With 30 seconds remaining in an AFC divisional playoff game between the Oakland Raiders and Pittsburgh Steelers, the Steelers were desperately trying to rally from a one-point deficit. Quarterback Terry Bradshaw scrambled back to pass to receiver John Fuqua, only to have that pass deflect off the helmet of Raider Safety Jack Tatum and hands of Fuqua, or just Fuqua, and be grasped by fullback Franco Harris, who scampered into the end zone for the winning score. A controversial “mistake” it still has its place as “The Greatest Play in NFL History” in the NFL Network’s 100 Series.

While on assignment in Hawaii once, I was introduced to a man there with his family. Vaguely familiar, I asked where he was from, why they were in

the islands, and more about his family. His oldest daughter was in Hawaii to play the harp, I learned. Thirty seconds after he walked away I realized who he was and felt immediately embarrassed at my lack of awareness. He was Ed Smart. His daughter, Elizabeth, had not long before been rescued from several months of captivity by a kidnapper. I should have known him: he and Ms. Smart had been on national TV for days and weeks pleading for her safe return. What a fool I was.

My friend who made the introduction later reported Mr. Smart’s gratefulness for a rare moment of anonymity and wanted to pass on that I had provided a rare moment to “breathe.” My ignorance had strangely served as a blessing.

We should take pride in our achievements. When working with Career Coaching clients and especially helping them prepare resumes, LinkedIn, and social media profiles, we invariably build stories that promote

their best accomplishments. When preparing them for job interviews, however, I’ll often present an alternative tactic. My questions may be something along the lines of “What is your greatest regret, mistake, or disappointment?” “What did you learn from it and what ‘good’ might have resulted?”

The point of the question is not to embarrass, but rather to gauge humility and self-awareness. More importantly, it helps to determine one’s ability to learn, recalibrate, and create something beautiful, even masterful, out of what may initially seem to have been the worst of circumstances. For without mistakes we might not today have:

Cornflakes.
Microwave Ovens.
Penicillin.
Super Glue.
Matches.
Post It Notes.

Or, even for that matter, Viagra.

A Pastor's Ponderings: The Parable of the Fig Tree

"Then he told this parable: 'A man had a fig tree, planted in his vineyard, and he went to look for fruit on it, but did not find any. So, he said to the man who took care of the vineyard, 'For three years now I've been coming to look for fruit on this fig tree and haven't found any. Cut it down! Why should it use up the soil?'"

'Sir,' the man replied, 'leave it alone for one more year, and I'll dig around it and fertilize it. If it bears fruit next year, fine! If not, then cut it down.'" (Luke 13:6-9, NIV).

The three trees I planted looked dried out and sucked up. What did I do wrong?

Years ago, I pastored a church that built a new facility. The congregation and I did the landscaping as money had run dry. I bought and donated three healthy pine trees for the project. Each tree stood over four feet tall and showed every sign of health.

I dug holes and plopped the trees in, carefully backfilling with good soil and watered liberally. I planted them with their root balls wrapped in burlap as I assumed the wrapping was biodegradable. Watching those trees over two years was discouraging as their branches drooped and their color lightened. They looked drawn in—as if they were holding their breath.

Leaving the burlap bag around the roots was the critical mistake, and the trees were starving from a lack of nutrients. I had to dig them up, remove the burlap and replant them. Jesus would call this "repentance." Today they are thriving and are

over 20 feet tall.

Christ encounters a similar human situation and gives a stern ultimatum in Luke 13:1-9, "Repent or Perish." This sounds harsh, but He tells the parable of the barren fig tree to explain.

Jesus likens God to a landowner who expects a harvest from his farm. He describes a tree that is taking up room and soil in the Lord's vineyard but is not producing fruit. The parable shows that uselessness in the Kingdom of God is unacceptable and invites disaster. The story also shows the patience of God as Christ the Gardner works on the tree to bring it to a condition of fruitfulness.

Jesus is calling attention to our urgent need for true repentance as fertilizer for our soul. If we are not growing and changing, we are dying. Only by turning to God and drawing life from Him can we develop fruitfulness.

William Barclay says in his "Daily Study Bible, The Gospel of Luke," "There are two kinds of people in this world—those

who take out more than they put in, and those who put in more than they take out. In one sense we are all in debt to life." The fig tree in our story is taking up space and not giving in return.

Christ's story begs the questions, "Of what use am I in the world? Am I being fruitful for the Lord?"

Jesus will dig around in our lives and fertilize it with His Presence, His Spirit and His word—if we give Him permission through repentance. Christ is the creator, sustainer and Lord of the universe and yet, He bows down to dig in our dirt, remove the burlap of our hard-heartedness to add fertilizer, so we can bring forth the fruit of the Spirit.

The great Puritan preacher, John Bunyan, addressing the tree in a sermon says, "Barren fig-tree! See how the Lord Jesus by these very words, suggesteth the cause of thy fruitless soul. The things of this world lie to close too thy heart; the earth with its things has bound up thy roots; thou art an earth-bound soul."

Feed your soul with the word and the Spirit to produce fruit in your life. Allow Jesus to dig around and fertilize your soul. Repentance is nothing less than a radically changed life that has uprooted worldly habits. Loosed to bear the fruit of love, joy, peace, patience, kindness, goodness, faithfulness, gentleness and self-control—life becomes an amazing adventure.

Look for ways to encourage and help others rather than promoting your own self.



30aEats.com Recipe of the Month; Sweet Cream Butter Broiled Lobster Tail

The Gulf Coast of Florida's Panhandle is a favorite beach escape, routinely voted among the prettiest in the world. And, while being known for its rolling dunes and sugar white sand, most may not know it's also a great dive destination.

For the underwater hunter, Northwest Florida is a gold mine, with miles of open water, and where the fish are plentiful. But, come late summer, the area becomes flooded with those trying to get their share of the Florida spiny lobster.

Though the regular 8-month lobster season is from **August 6th through March 31st**, the 2-day mini season is always the last consecutive Wednesday and Thursday in July, beginning at 12:01 am on Wednesday, and ending at 12:00 midnight on Thursday.

If wanting to dive into the lobster on your plate instead of the salty Gulf, follow your

nose to the most succulent crustaceans at Brotula's Seafood House & Steamer in Destin, where you can get your warm water tail steamed or boiled with choices of spices, and served with Cajun or drawn butter.

Salt air and sandy feet lead to seafood shacks serving the freshest available, and in Seaside, Florida it can be found at The Shrimp Shack. Heavenly Dawson, former co-owner of the eatery with her husband Bill, said, "Shrimp Shack offers the best warm water lobster rolls available in the Panhandle. They are just steamed and served with lemon wedges and drawn butter." The moist chunks of perfectly prepared lobster cuddle together



nicely in the fresh baked bun.

The Florida spiny lobster has no big, crushing claws, and with all of its meat in the tail, cooks up

nicely on the grill. Foodies love to debate on whether to cook the lobster shell up or down. Longtime Miramar Beach local and my dad, Tom Guttery, makes a b-line to Destin Ice & Seafood for the freshest catch, prefers the grill method, and said, "I like to start them out shell down,

it protects the meat. Baste them in olive oil and unsalted butter, let them cook 6 minutes up, then flip them over and cook them 2 minutes down. The most important thing is not to over cook the tails!"

Sweet Cream Butter Broiled Spiny Lobster Tails

Ingredients
4 (6- to 9-ounce) spiny lobster tails, split open in the shell

1/4 stick unsalted butter, softened at room temperature

Sea salt to taste

Fresh ground pepper to taste

Preheat the oven broiler on medium high.

Instructions

Place all 4 of the lobsters on a cookie sheet and make sure they are opened up down the middle. Evenly spread the softened butter over each of the lobster tails' meat. Lightly season each lobster tail with salt and pepper.

Place lobsters in the oven on the middle rack under the broiler. Let the lobster cook under the broiler for about 7 minutes or until just barely cooked throughout.

Remove lobsters from the oven and let cool slightly. Serve lobster tails warm with fresh lemon or lime. Coconut rice and steamed broccoli are also nice sides.

Fresh Catch at the Angry Tuna

Even though it may be a few hundred feet away from the sand, this beachy bar will have you feeling fresh off the boat. Tim Jacobi and Don “DJ” Janovyak have been pelagic fishermen for over 40 years and grew up on big boats fishing recreationally, a popular activity in this area. With their new restaurant, they wanted to honor that and celebrate the fish caught on big rigs off Pensacola and Gulf Shores. They opened in late 2018, intent on emulating the vibe of paradise and putting it all into one building on the beach.

Curious about how they got their unusual name? Tim explains that pelagic fish “dart at bait and jump [...] they move so fast that it looks like they’re angry.” The nature of the fish has become a sort of groundwork for the names of the food and drink they serve.

Menu Spotlights

Angry Ahi Tuna Oysters –

Inspired and created by Tim’s wife, Mary Beth. She was eating a seared tuna appetizer and then had a dozen oysters brought out to their table. When she got down to the last bit of her dishes, she combined them and fell in love with it. They are proud to offer the largest oyster bar on the beach at 26.5 ft long with 3 shucking areas and a pellet grill that gives the oysters a wonderful and smokey mesquite flavor if you like them cooked.



Cat 5 Hurricane – A drink big enough for two, this knock-out cocktail has five different kinds of rum AND a floater. If you can



finish the drink, you get a t-shirt! It was inspired by Hurricane Michael which devastated the Florida Panhandle. The Angry Tuna was open for only 9 days before the hurricane hit. But instead of letting that get them down, they took all the food they had and were able to feed the community. They cooked for all the emergency workers and were one of the few places that had electricity when it happened.

Angry Punch – The Tom Cruise cocktail, this is the drink you sip on when you’re out on the boat watching dolphins swim by. Super fruity and light, when you think about a vacation, this is your drink.

Seared Tuna Sliders – A house favorite, this dish comes with fries and showcases two seared Ahi Tuna sliders served on top of lettuce and ginger topped with wasabi cucumber sauce.

Weihenstephaner – A beer made by the monks, known as the oldest beer in Germany.

Hook and Cook – Bring in your fresh catch right off the boat and they’ll cook it for you in house, served with two sides.

If you’re looking for a lively spot to enjoy the view and ocean air, the atmosphere inside the Angry Tuna will feel like home to you. They have live music on the weekends, and you’ll be amazed when you walk around the restaurant. Guests are welcome to bring in their own pictures to put alongside the memories that the walls hold.



Studio 237 Music Lessons; Steps to Success!

August is when students return to school and resume or begin music lessons. I like to reflect on the past year and then find ideas on how to improve my student's musical learning experience. There are many great reasons why a child desires to play an instrument and my goal is to keep their learning momentum rolling. Parents play an intricate role in maintaining their child's momentum. I want to inspire parents with a few steps for success with music lessons.

Have a Goal to take lessons for three months. Practice three or more days a week at the same time and place for 20 to 30 minutes. Depending on the student's age or personality, you may need to oversee their practice. Arrive at your lesson on the same day, same time, every week. Avoid constant rescheduling of your lesson.

Obtain a quality instrument. When renting an instrument, choose the medium or higher quality level which helps the student sound better, learn quicker, and is easier to play. For pianos, I recommend a used real wood upright or a quality digital keyboard including a stand. Since guitars, violins, and drums are made for one's size and style, ask for your teacher's recommendation.

Create a music zone in your home. This is a place set aside for the student to practice, play for fun, and create songs. Choose a

quieter cheerful area for greater focus. Purchase a music stand to hold music books. Designate a particular chair or bench for seating. A full-length mirror on the wall/door is helpful for wind and string instrument practice. Musical wall art sets the mood for learning.



Supplies: Choose a music themed book bag. Get a three ringed binder and hole punch and then help them organize their sheet music, lesson plans, and handouts. Have a pencil, pen, highlighter available during practice. Wind instruments may need a set of reeds, reed guard holder, cleaning cloths, valve oil, and mouthpiece covers. String instruments may need rosin, neck rests, tuner, and a set of extra

strings.

Rewards! Students of all ages (even adults) love rewards for achievement. Start with small goals and reward quickly. Such as: practicing for 2 days in a row, playing a song for you, or being able to recognize three notes. Depending on their age, a child's

reward might be verbal affirmation, a hug, stickers, food item, points towards an item/event, or extra play time.

The greatest reward of music lessons is taking pride in one's accomplishments and developing life skills which enhance many aspects of one's: study, intelligence, grades, coordination, organizational skills, creativity, communication, confidence, poise, memory, test taking, preparation,

planning, problem solving, presentation, finishing, responsible work habits, teamwork, positivity, relaxation, and personal expression.



A Quick Guide to Self-Managing a Condominium Community Association

Some Condominium Associations, particularly in smaller communities, often consider self-managing association duties in lieu of paying a full-time association management company. While these companies can be a valued asset for large communities, smaller communities may not be able to easily support the cost of their services. Additionally, owners who are considering managing their own association have a vested interest in the appearance and maintenance of the community and are in the best position to evaluate its needs. By gaining a thorough understanding of the different functions involved, achieving

self-management becomes much more conceivable.

Most association tasks can be categorized into two main groups. The first group is the Community Functions and the second, the Financial Functions. Here is a list of the main tasks for each:

Community Functions –

- Field owner/renter inquiries.
- Track vendor performance; order needed repairs and maintenance.
- Organize Board & Owner meetings, assist at meetings, keep minutes.
- Maintain owner/member directory. Store association historical files and documents.
- Enforce compliance with Community Rules & Regulations.

Financial Functions –

- enter and pay bills
- book dues received, send delinquent notices as needed reconcile bank accounts, provide financial reports
- file annual tax return

A first step toward self-management might be to set up

the community email and phone.

Owners or their guests may need to contact the Association regarding issues with the common areas like elevators, pool, parking, entry gates or other association property. An Association email address can be set up and might include the community's name, e.g., Beach.condos@gmail.com. For phone contact, an answering service like AnswerFirst can provide a dedicated local phone number for the Association. They can put together a script including a greeting identifying the Association, inquire as to the reason for the call and then contact the designated Association member to relay the information.

While vendor management duties can be shared by the various owners and officers, it is best that there be a single contact for each of the vendors to avoid confusion. Owners should become familiar with each vendor contract, noting the type of services and how often they are to provide them.

Board and owner meetings need to comply with state statutes, particularly chapter 718 for condominiums, making sure that proper notices are posted in advance of the meeting as well

as following voting procedures for any Association business. Annual Board certification courses, which are usually provided by local attorneys specializing in condo law, are a good source for this information.

As the Association is required to maintain community records, a cloud-based service like Dropbox will serve well. Folders for each category can be created like board and owner meeting minutes, insurance contracts, vendor contracts, or any other items that have been in the Associations historical files. Access to these files can be provided to all board members.

Community Rules & Regulations are intended to maintain order and create an atmosphere of harmony. A review of the Rules document may be in order to improve compliance. Adding bullet points, underlines and bold type to highlight important parts and listing the most important rules first can add clarity to the document. Copies should be posted in multiple conspicuous locations on property and sent frequently to owners and rental agents.

Some local banks offer a lock-box service to receive condo dues

payments and will send payment coupon books directly to each owner as well. A mailbox for the Association can be set up at a USPS or UPS location to receive bills and other Association mail. Most small communities only write perhaps a dozen checks for vendors and utilities once-a-month. Easy-to-use accounting software like Quickbooks can be used for all Association accounting with an outside accounting service assisting with set-up, financial reports and filing the annual tax return.

The key to successful transition to a self-managed condominium association is having owners committed to taking on the challenge, a well-thought-out plan, and to have the support of an experienced professional to assist before, during, and after the transition.



One of the first things you should know is what the heat index is. The heat index is the “feels like” temperature to the body when relative humidity is combined with the air temperature. It could be 93° with a “feels like” 102°. Heat indexes of 103° or higher are considered dangerous; use caution when planning beach days or outings with a high heat index.

While checking the weather forecast and heat index, be sure to check the UV forecast. Checking UV (ultraviolet radiation) should become as much of a habit as checking the weather. UV forecasts include many factors, so don’t assume cloud cover or lower temperatures mean low UV. Anyone who has gotten a sunburn on a cloudy day understands. Checking UV is particularly important if you plan to spend several hours outside and even more so at the beach where UV radiation can be increased by reflecting off our white sands and water.

Wear reef safe sunscreen. The best way to protect yourself from UV radiation is by



staying in the shade or wearing protective clothing. Another way is slather on reef safe sunscreen. Be sure to check the back of the sunscreen bottle. Some sunscreens contain chemicals that can harm marine life including corals, fish and even dolphins.

Get to know the sand between your toes. We have some of the whitest beaches in the world and all thanks to the Appalachian Mountains and the Apalachicola River. 20,000 years ago, when the world temperatures began warming after the last Ice Age, large volumes of water were carried by rivers to the world’s oceans. The Apalachicola River carried small quartz particles to the

Gulf of Mexico and continues today. These unique quartz particles created our shorelines and beautiful white beaches.

Share the shore. Our beaches are great, but they aren’t ours—we’re all just visitors. Snorkeling, diving and even sitting, one can experience a whole world coexisting at the beach. Share the shore and take the pledge that you will find out how to keep yourself and the marine animals around you safe. As tempting as it is, keep your distance from marine life and leave that shell souvenir behind. Some shells play a vital role in our beach ecosystem and taking some washed up items can actually be illegal. If you are looking for that perfect souvenir, try an airbrushed t-shirt reading, “My friends visited the beach and all I got was this lousy t-shirt.”

What's in Your Business Insurance Program?

Whether you are a sole proprietor, partnership, LLC, joint venture or corporation, the type of business insurance you'll need depends on the type of business you own, the services you provide, and how many employees you might have. All of this information will be used to help provide you with recommendations for the type of business insurance you'll need. Other basic criteria to determine the proper business insurance program will be your specific trade, physical location, number of employees, estimated revenue and the services provided.

If you plan on running a successful business, then one should definitely plan on getting business insurance. Without this coverage, you might end up having to pay out-of-pocket for property damage, accidents, or lawsuits from unhappy clients. Needless to say, all of these very-real possibilities can be devastating for both your business and your personal finances if you don't have business insurance. Depending on what you do, some clients won't want to work with you unless you are insured, especially if you're in a business where you work on a client's property and are at

risk for causing damage. And in some cases, the state may legally require you to carry some type of business insurance coverage, like workers' compensation or general liability coverages.

For small to medium-sized businesses, **Business Owners Policies or BOPs** as they're referred to, are a great product combining protection from major property and liability risks in one package, similar to your homeowners' policy. They cover things such as:

1. Property insurance for both the building and contents owned by the company. This includes furniture, fixtures, and inventory. Your policy should always be written on the Special Form which is broader coverage, changing the policy from a named peril to an open peril policy.

2. Business Income & Extra Expense insurance, which covers the loss of income resulting from a fire or other catastrophe that disrupts the businesses operation. It can also include the extra expense of operating out of a temporary location.

3. Liability coverage which protects your company's legal responsibility for the harm done to others. This harm can be triggered by you or your employees for what they do or fail to do in your operations that may cause bodily injury or property damage due to an error in providing a service, faulty installation or defective product. It also covers the cost of your defense as businesses can be sued even if they are not negligent or did nothing wrong.

In conjunction with the BOP, there are additional coverages that can be purchased depending

on the type of business you have and your exposures. You should always consult your agent and purchase the correct coverages for your particular risk.

And other exposures and additional areas of coverages for a business to consider:

Business Auto coverage to protect your owned business vehicles, hired and non-owned auto and your employees when they drive on company time.

Crime Insurance to protect your business against burglary, forgery, computer fraud, employee dishonesty and other crimes.

Cyber Liability coverage for computer attacks and damage to electronic data and computer systems.

Employee Practices Liability Insurance (EPLI) to protect against employee lawsuits.

Professional Liability insurance (E&O) to protect

against lawsuits for negligent acts, errors and omissions that result in financial losses during business activities.

Inland Marine coverage to protect property, goods or equipment in transit and over water or land.

Umbrella coverage to obtain higher limits over underlying policies you have in place.

Workers' Compensation to protect employees against accidents and diseases at your workplace.


